COMMITTEES MAY BE TERMINATED OR REORGANIZED BY THE BOARD WITHOUT AMENDING
THE BYLAWS. IN GENERAL, PROGRAM COMMITTEES OF THE BOARD SHALL BE THOSE
COMMITTEES RESPONSIBLE FOR ADVISING THE BOARD WITH RESPECT TO EXHIBITIONS,
EDUCATIONAL PROGRAMS, DEVELOPMENT AND MEMBERSHIP PROGRAMS, MARKETING AND
OTHER ACTIVITIES UNDERTAKEN IN PURSUANCE OF VESTERHEIM'S MISSION AND THE
USE OF VESTERHEIM'S COLLECTIONS AND FACILITIES IN SUPPORT OF THOSE PROGRAMS
AND ACTIVITIES.

NO FEWER THAN THREE (3) TRUSTEES SHALL SERVE ON EACH COMMITTEE.

THE CHAIR OF THE BOARD OF TRUSTEES SHALL APPOINT THE CHAIR AND MEMBERS OF
EACH COMMITTEE WITH THE APPROVAL OF THE BOARD OF TRUSTEES.

MEMBERS FROM THE GENERAL MEMBERSHIP MAY BE REQUESTED BY THE CHAIR OF THE
COMMITTEE TO SERVE AS NEEDED, SUBJECT TO THE APPROVAL OF THE CHAIR OF THE
BOARD OF TRUSTEES.

ANNUAL REPORTS FROM ALL STANDING COMMITTEES SHALL BE SUBMITTED IN TIME TO
BE SENT TO ALL MEMBERS OF THE BOARD OF TRUSTEES WITH THE CALL OF THE FIRST
MEETING OF THE FISCAL YEAR.

WHENEVER THERE IS OR APPEARS TO BE A CONFLICT BETWEEN THE INTERESTS OF VESTERHEIM AND THE INTERESTS OF A TRUSTEE OR A PERSON CLOSE TO HIM/HER, THE TRUSTEE IS REQUIRED TO PROVIDE A FULL AND FAIR DISCLOSURE IN SUFFICIENT TIME TO PERMIT PROPER STEPS TO BE TAKEN TO INSULATE THAT TRUSTEE FROM INFLUENCING THE DECISIONS RELATED TO SUCH CONFLICT. IF THE TRUSTEE IS PRESENT WHEN A VOTE IS TAKEN IN CONNECTION WITH SUCH A QUESTION, THE TRUSTEE SHOULD REFRAIN FROM DISCUSSING THE ISSUE AND ABSTAIN FROM VOTING ON THE MATTER. THE ABSTENTION WILL BE NOTED IN THE OFFICIAL MINUTES. IN A SITUATION WHERE THE CONFLICT IS SO GRAVE IT CANNOT BE RESOLVED, THE CHAIR OF THE BOARD OF TRUSTEES MAY REQUEST, BUT MAY NOT DEMAND, THE TRUSTEE'S RESIGNATION. WHENEVER A MATTER ARISES THAT COULD BE PERCEIVED AS A CONFLICT BETWEEN THE INTERESTS OF VESTERHEIM AND AN EMPLOYEE OR AN EMPLOYEE'S FAMILY, THE EMPLOYEE SHOULD BRING THE MATTER TO THE ATTENTION OF HIS/HER SUPERVISOR FOR RESOLUTION.
